



HOUSE RULES

Status July 2021

The house rules determine the rights and obligations of visitors during their stay on the premises and in the function areas of Station Berlin Event GmbH (hereinafter also referred to as "venue"). The respective event organizer and Station Berlin Event GmbH as the operator shall monitor compliance with the obligations towards the event visitors.

The premises of the lessor (STATION-Berlin) are private property. The operator is Station Berlin Event GmbH. It exercises the domiciliary rights in addition to the respective event organizer.

Entering the STATION-Berlin is at your own risk. The lessor is not liable for personal injury or damage to property caused by third parties.

The premises and the halls of the location are video-monitored.

Only visitors with a valid admission ticket or guests of the organizer are permitted to stay in the location during public events with ticket sales. Visitors must take the seat indicated on the admission ticket for the respective event and use only the entrances provided for this purpose. Upon leaving the location, the admission ticket loses its validity.

All facilities of the location are to be used respectfully and with care. Within site, everyone must behave so that no one else is harmed, endangered or obstructed, or inconvenienced more than is unavoidable under the circumstances. Smoking is prohibited, including e-cigarettes.

Rallies or demonstrations on the premises are not permitted. In addition, we do by no means tolerate to express, use or disseminate political propaganda, acts, racist, xenophobic, or other radical, predominantly right-wing, slogans, gestures, emblems, or symbols.

Commercial photography and filming in the outdoor area and the halls are not permitted. Visitors may not display, sell, or distribute writings and goods of any kind, use sound systems or loudspeakers, etc.

Driving on the grounds and in the halls with vehicles is only permitted with special permission. Likewise, cabs may not enter the site.

The team in charge of the halls, buildings, and open areas may order their evacuation for safety reasons. However, in the event of an evacuation order, all persons present in the location and on its premises must comply with such orders immediately and leave the site directly

Checkroom, bag, and body checks: For security reasons, the team in charge may order a ban on carrying bags and backpacks and an obligation to hand in purses, backpacks, and checkroom items at the usual local rates. If no such prohibitions exist, visitors must expect bag and body checks, including checks of any containers, coats, jackets, and capes carried



for their contents. Visitors who do not agree to the security of objects that could endanger the event or visitors by the admission or security service may not participate in the event. Rejected visitors are not entitled to a refund of the admission fee. No liability is accepted for valuables, money, keys in bags, backpacks, or checkroom items handed in!

Persons who are visibly under the influence of alcohol or drugs will be excluded from the event and must leave the venue. Rejected visitors are not entitled to a refund of the admission fee.

The provisions of the Youth Protection Act apply. In addition, young people who have not yet reached the age of 14 may only be on the premises if accompanied by a parent or a legal guardian. Special regulations apply only if expressly posted at the ticket counters and admission areas.

It is prohibited to carry the following items:

- Weapons or dangerous objects, as well as anything that, if thrown, could cause bodily harm to persons.
- Gas spray bottles, corrosive or colouring substances, or pressurized containers for highly flammable or harmful gases, except for commercially available pocket lighters and hair spray
- containers made of fragile or splintering material
- Fireworks, rockets, Bengal fires, smoke powders, flares, pyrotechnic objects
- Mechanically and electrically operated noise instruments
- All beverages and food brought to the event
- Animals (except for guide dogs, guide dogs for the blind, and service dogs)
- Racist, xenophobic and radical propaganda material
- Sound or image recording devices for commercial use

Right to one's image: If photographs, film, and/or video recordings are made in the area of the location by employees of Station Berlin Event GmbH, by the organizer, or by companies commissioned by the organizer for reporting or advertising purposes, the recording activity may not be obstructed or impaired in any other way. These house rules inform all persons entering or staying that photography, filming, and video recording is not permitted in the site area. Furthermore, recordings of participants and visitors to events may be published without the consent of the person concerned, following the provisions of § 23 of the Law on Copyright in Works of Fine Arts and Photography (KunstUrhG)

Volume at musical events: The organizer is obligated to inform the visitors if his event can reach sound levels in the audience area that can contribute to the development of permanent hearing damage. To reduce the risk of harm, we recommend, in particular, the use of hearing protection. At such events, the organizer shall point out the corresponding risks in the entrance area of the location and shall provide the visitors with hearing protection plugs free of charge upon request. The regulations according to TA Lärm (protection of the neighbourhood), DGUV V3 (safety of employees), DIN 15905 Part 5 (protection of the audience) apply.



STATION BERLIN

The landlord reserves the right to refuse entry to visitors with small children and infants due to the high noise level.

House bans apply to all current and future events in the meeting place. To lift the house ban, we need a written application including a reason. We will decide upon such applications within three months.
